II. APPROVAL OF AGENDA:

MOTION: Mr. Weinberg moved, Mr. Spell seconded, to approve the agenda as amended. The motion passed unanimously (5-0-0).

IV. APPROVAL OF MINUTES:

MOTION: Mr. Spell moved, Mr. Weinberg seconded, to approve the Minutes of June 21, 2016 as amended. The motion passed unanimously (5-0-0).

V. REVIEW OF EVENT CALENDAR/RESERVE PROJECTS: Mr. Foschi reported that in terms of reserve projects, the boilers were assessed and the recommendation seems to be to overhaul and replace components; however, Emcor will be sending experts to do a full inspection and give an estimate on replacement. The report gives 2 options: to replace the burner which will not improve efficiency and to replace the boilers with more energy efficient ones. Mr. Foschi then addressed the electric risers and said that ESI Engineering did random samples of units and recommended replacing the ones on the 10th floor which were not plastic PVC. Turning to the calendar, Mr. Foschi said that the trash compactor was checked and trash chutes were cleaned in June. In August, he said, he will send letter to the 10th floor residents on fire safety. He will also check with Haute Papier about the lease for L3. A. <u>President</u>: No report.
B. Treasurer: Mr. Spell reported that operating cash was \$57,972; operating

reserves were \$1,979; replacement reserves were \$1,453,265; total assets were \$1,665,672. Mr. Foschi then gave the Variance Report for June 2016 and a report on delinquencies. C. <u>OA Representative</u>: Mr. Turman said he had no report and that the Board will meet on Thursday.

D. <u>Manager</u>: Mr. Foschi reported on the following items:

1. Cleaning Services: Tabled.

2. <u>Unit #605 Flooring</u>: Mr. Foschi said that the renter has vacated and the unit was rented but that he hired a contractor to install laminated flooring and to paint. He suggested that the Board consider remodeling the bathroom and kitchen.
